## E. Treasurer Report

- Nadia Demers reported early registration numbers are looking good.
- Gaming grant has been submitted expect response by September 23<sup>rd</sup>.
- Need to track down \$20K for jersey sponsorship. Kevin Sopp will lead with support from others around the table.
- Need to confirm if Michelle Gemmell will lead fundraising event and suggested to also engage with Jeremy Robb.

# F. Risk Manager

• Aaron Hoverd has volunteered for the Risk Manager position vacated by Peter Armistead. After discussion, motion to appoint and carried unanimously. (LT/PA)

### G. **Draw Winner**

• WMHA received 136 registrations before June 10<sup>th</sup> and Annie Akehurst wins the random draw.

## H. **Director of Hockey**

- Leveraging Squamish RFP for DoH position. Need to edit for specific WMHA requirements. Board comments by July 2<sup>nd</sup>.
- Support for commitment to two-year term with understanding WMHA has surplus cash reserves in the event gaming grants are not sufficient to cover the incremental expense.

## I. Season Start-Up

- Ice booked for Back to Hockey camps but need coaches. Maybe use older kids as on-ice helpers.
- Miles not available for goalie camps going forward.
- Maintain price at \$100. Sessions start at 3:30.
- Ice secured for try-outs on the weekend of September 9<sup>th</sup>. Evaluators need to be confirmed.
- Skills session and two games. No schedule yet.
- Ice reserved on 7<sup>th</sup> and 11<sup>th</sup> for Bears.
- Regular season ice starts on September 11<sup>th</sup>.

## J. Registration

• Currently sitting at 146 and only missing about 20 returning players net of families that are leaving Whistler.

- U9 will have to be closed at 18 but would open again at 26, which enables transition to two teams.
- U11 has healthy numbers. U11C closed at 17. U11 Rep needs to retain all 13 registered players, including the three females.
- May be able to accommodate a U11F team but registration numbers still at least five short even with three U9 playing up. Noted that a U11F team would play in "West" division of Lions Gate League so still potential games in Richmond and Delta ... but not in the Fraser valley.
- U13 will be two teams up to 17+2. Currently 26 indicating Rep, including three goalies, and 8 indicating house.
- U15 is the most challenging division with still much uncertainty until pending registrations and Bears' releases are resolved.
- U15C numbers are low currently at 9 with no goalie. Could pull from U13 where we have numbers?
- U15F may end up with too much for one team but not enough for two teams currently 16 registered with 9 pending.
- U15 Bears will not affiliate from U13.
- U18C is closed based on returning players and anticipated Bears' releases.
