F. Season Start-Up Debrief

- Back to hockey camps were well subscribed
- Too long for one coach to do all four sessions; recommendation to split sessions up and a coach does two sessions
- Maybe U15/U18 group goes first so parents of younger players have time to get players to the rink
- Coaches and on-ice helpers to help paid coaches with sessions so that drills run more smoothly and paid coach instruction time is maximized
- Suggestion made that volunteer coaches sign-up to volunteer at these sessions so we know how many adults are available at each session; especially needed at the younger ages.
- Try-outs went well and the format this year worked better for assessment as there were more assessors watching and they had more time to write up their evaluations
- On-ice helpers at skills sessions help everything run more smoothly
- Suggestion made to move first session of try-outs to Friday (and not offer back to hockey camp on that day) so that evaluations can be done sooner and notifications to players and families sent out sooner.
- The use of U-18 players on the benches for the try-out game sessions worked well
- Suggestion made to make try-out process more clear to players and families (how players are assessed, etc.) good example can be found on the North Van Minor website
- Explain how the scoring system works; meeting with parents and players before ice sessions were two ideas

G. Team and Ice Schedule Updates

- U15FC is now Wednesday afternoon and U15C is Friday afternoon
- U18 has 18 players (1 waitlist) waiting on goalie; U15FC has 16 players (includes Squamish players) 1 goalie (1 in process); U15 has 13 players 1 goalie; U13C has 14 players (waiting on goalie from U13A tryout cuts); U13A working group of 19 players and 3 goalies, final selections made by Tuesday, September 19 by Jesse Williamson; U11C has two teams of 12; U11A has 11 players and 1 goalie; U8/U9 has 31 players and 2 goalies; U6/U7 has 16 players

H. Coaching Update

- Only two teams currently need support with coaching: U6/7 and U13C. U6/7 has a new parent that will need support and U13C has no head coach as of yet.
- Amanda will be the AC for U11A, running practises and home games HC Marc
- Jesse will be the AC for U13A, running practises and home games HC parent?

I. U7 / U9 Assessments

- Paid coach will assess U8/U9 this coming weekend to determine whether we have a minor and major or two minor teams; this recommendation will guide board's decision of what will be declared.
- If no major option at U9, suggestion that any strong U9's could be give option to play U11C
- Also noted that same could be done for U13's that don't make U13A rep team, that they could play U15C
- Trying to get paid coaches to help with first weekend of U6/7 practises as no experienced coaches at this age

- Reminders have been sent out for people to update paperwork
- CRC good for 5 years but BC Hockey only says good for 3 years
- Website link (on WMHA site) gives all the info for volunteers and what they need for paperwork

K. Other Business + In Camera

- Website needs updates; manager checklist is old and board minutes have not been updated
- DOH position application deadline is September 15, 2023; proposals will be shared with board and then a review committee will look at top candidates and recommend next steps; interviews, etc.
- Change room issues around designated female change room; communication with members and clear signage as we have integrated teams with both genders
